That volunteer is called a Court Appointed Special Advocate®, or CASA. Many children are appointed a CASA to help them maneuver the Child Protection Services and Foster Care systems. CASAs become a consistent presence in a child's life until he/she is placed in a safe and permanent living situation! The CASA's role is to give that child the attention he/she NEEDS and DESERVES, and ultimately make a better life for him/her by helping to assure that safety and well-being are being met.

CASA is hosting our **CRAWFISH for CASA** event at Downtown 301 Event Center on Friday, April 28, 2017, at 7 p.m., with doors opening at 6:30 p.m. in an effort to help strengthen our foundation to support these children in need.
